Message from the Executive Director

On June 1, 2015, I began my tenure as the first Executive Director of the Rock River Free Clinic (RRFC). I will start by stating how fortunate our county is to have such a valuable resource for those without health insurance. I have learned that we are one of the only free clinics in our state with a full-time physician. This allows our clients to establish a relationship with a single primary care physician who knows them personally and cares for them which can only benefit their on-going health.

During my first six months, I also learned that although one might intuitively think everyone in our community should have health insurance based on the provisions of the Affordable Care Act, this is not the case. In reality, there are many who are still not able to afford the insurance options available to them. In Jefferson County, there are over 5,000 of our community members without health insurance. Unfortunately, those without insurance find themselves in hospital emergency rooms sometimes taking care of non-urgent health issues or because they have left health issues go too far. One of our primary goals is to ensure that all in our midst have access to primary care on a consistent basis which will indeed serve to elevate the overall health of our community.

In October 2015, RRFC revised our screening program. Every new client must meet individually with a volunteer screener within 30-days of their initial visit with the physician. The screener reviews the client's income documents and determines if the RRFC is the best possible venue for the client's on-going care. If the client is eligible for BadgerCare or Marketplace Insurance with subsidies, the screener is able to assist the client in starting the application process.

The RRFC is extremely grateful to our partners—Fort Healthcare, Jefferson County, United Way, Tomorrow's Hope and those individuals who support our cause as they allow us to continue to serve as an important health safety net for our community. A heartfelt thanks!

Through universal screening, those in need of Behavioral Health services will be identified and care will be coordinated with Jefferson County Human Services. This is an exciting expansion of our services!
